WHEREAS, On July 20, 2022, Alderman Brendan Reilly and Alderman Scott Waguespack, as co-chairs, established the Chicago City Council Taiwan Friendship Caucus; and

WHEREAS, The Chicago City Council Taiwan Friendship Caucus is initiated during the tenure of Johnson Chiang, director general of Taiwan's Taipei Economic and Cultural Office in Chicago; and

WHEREAS, The Chicago City Council will be the first City Council in the U.S. Midwest to establish a Taiwan Friendship Caucus, and the caucus has bipartisan and multi-caucus support; and


WHEREAS, Taiwan shares the same values of freedom, democracy, human rights, the rule of law, peace, and prosperity with the United States and the City of Chicago; and


