O2015-1532 A substitute ordinance to amend Chapters 4-4 and 4-60 of the Municipal Code of Chicago regarding summary closure of establishments deemed a public safety threat. (Mayor Emanuel and Alderman Reilly)

O2015-1405 An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (7.86) to allow the issuance of additional alcoholic liquor licenses on portion of 83rd Street. (Alderman Holmes, 7th Ward)

O2015-2669 An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (25.154) to allow the issuance of additional alcoholic liquor licenses on portion of Hoyne Avenue. (Alderman Solis, 25th Ward)
