**Two ordinances** to amend the Municipal Code of Chicago designating precincts of the 13<sup>th</sup> Ward as Restricted Residential Zone prohibiting additional shared housing and vacation rentals. (Alderman Quinn, 13<sup>th</sup> Ward)

**O2019-312** An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (21.183) to allow the issuance of additional alcoholic liquor licenses on portion of Ashland Avenue. (Alderman Brookins, 21<sup>st</sup> Ward)

**O2019-311** An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-023 (28.45) to allow the issuance of additional packaged goods licenses on portion of Madison Street. (Alderman Ervin, 28<sup>th</sup> Ward)

**O2019-316** An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (40.10) to allow the issuance of additional alcoholic liquor licenses on portion of North Clark Street. (Alderman O'Connor, 40<sup>th</sup> Ward)

**O2018-9334** An ordinance to amend Section 4-60-023 of the Municipal Code of Chicago lifting subsection 4-60-023 (47.52) to allow the issuance of additional packaged goods licenses on a portion of Ravenswood Avenue. (Alderman Pawar, 47<sup>th</sup> Ward)
