O2018-2340 An ordinance to amend Chapters 4-5, 4-64 and 7-32 of the Municipal Code of Chicago regarding electronic cigarettes and tobacco products.
(Mayor Emanuel and Commissioner of Public Health)

O2018-1042 An ordinance to amend the Municipal Code of Chicago lifting subsections 4-60-023 (12.280) and 4-60-023 (12.281) to allow the issuance of additional packaged goods licenses on portion of Archer Avenue. **(Alderman Cardenas, 12th Ward)**

O2018-2361 An ordinance to amend the Municipal Code of Chicago designating the 46th precinct of the 13th Ward as Restricted Residential Zone prohibiting additional shared housing and vacation rentals.

O2018-2382 An ordinance to amend Section 4-60-023 of the Municipal Code of Chicago to disallow additional package goods licenses on portion of South Ashland Avenue.
