1. In the event marijuana is legalized, should the City of Chicago appropriate revenue from the sale of marijuana to increase funding for Chicago Public Schools?
2. Should the City of Chicago seek that the State of Illinois create a homeowners property tax exemption for families in municipalities of over 500,000 that have lived in their home for over 10 years and whose income is under \$100,000?
3. Should the City of Chicago ban the use of plastic straws within the corporate city limits?
