An ordinance authorizing sundry amendments to the Municipal Code of Chicago necessary for the organization, reorganization, and jurisdiction of various departments and other matters necessary for the conduct of government including the establishment of the Department of Housing (management ordinance).
2. An ordinance authorizing sundry amendments to the Municipal Code of Chicago necessary to correct and/or update various sections.
3. An ordinance authorizing the execution of an intergovernmental agreement between the City of Chicago, the County of Cook, and the Chicago Transit Authority necessary for the allocation of motor fuel tax funds pursuant to the Regional Transportation Authority Act.

11. An ordinance authorizing the execution of an Intergovernmental Agreement between the City of Chicago and the Chicago Housing Authority (CHA) concerning the Homemod Program under the CHA Housing Choice Voucher Program.
12. An ordinance authorizing a transfer of funds within the City Council Committee on Human Relations.
