An ordinance authorizing and directing the Department of Transportation to exempt PUBLIC BUILDING COMMISSION/CITY OF CHICAGO from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 6000 North Broadway Street.

**(27) CHICAGO HOUSING AUTHORITY - O2012-1400**

An ordinance for a proposed vacation of the Easternmost North-South, and a portion of the previously unvacated East-West alleys, all in the block bounded by West Walton Street, West Locust Street, North Sedgwick Street and North Orleans Street.
