**O2018-8120** An ordinance to amend Section 4-60-023 of the Municipal Code of Chicago to disallow additional package goods licenses in portions of the 42<sup>nd</sup> Ward. (Alderman Reilly, 42<sup>nd</sup> Ward)

**R2018-1237** A resolution calling for hearing and independent investigation of allegations of abuse at Aurora Chicago Lakeshore Hospital and address status of license to do business as hospital dedicated to treatment of children with psychiatric needs. (Aldermen Burke and Laurino)
