**O2013-6108** A substitute ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (6.13) to allow the issuance of additional alcoholic liquor licenses on portion of 69<sup>th</sup> Place and South Chicago Avenue. (Alderman Sawyer, 6<sup>th</sup> Ward)

**O2013-7597** An ordinance to amend Section 4-60-023 of the Municipal Code of Chicago to disallow additional package goods licenses in portions of the 9<sup>th</sup> Ward. (Alderman Beale, 9<sup>th</sup> Ward)

**O2013- 7585** An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-023 (13.71) to allow the issuance of additional packaged goods licenses on portion of 63<sup>rd</sup> Street. (Alderman Zalewski, 23<sup>rd</sup> Ward)

**O2013-7736** A substitute ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (25.148) to allow the issuance of additional alcoholic liquor licenses on portion of Damen Avenue. (Alderman Solis, 25<sup>th</sup> Ward)

**O2013-7612** An ordinance to amend Section 4-60-022 of the Municipal Code of Chicago to disallow additional alcoholic liquor licenses on portion of Chicago Avenue. (Alderman Reilly, 42<sup>nd</sup> Ward)

**O2013-7607** An ordinance amending the Municipal Code of Chicago by including the 45<sup>th</sup> Ward in permitting the "booting" of vehicles on private property by private firms. **(Alderman Arena, 45<sup>th</sup> Ward)**
