O2013-6108 A substitute ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (6.13) to allow the issuance of additional alcoholic liquor licenses on portion of 69th Place and South Chicago Avenue. (Alderman Sawyer, 6th Ward)

O2013-7597 An ordinance to amend Section 4-60-023 of the Municipal Code of Chicago to disallow additional package goods licenses in portions of the 9th Ward. (Alderman Beale, 9th Ward)

O2013- 7585 An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-023 (13.71) to allow the issuance of additional packaged goods licenses on portion of 63rd Street. (Alderman Zalewski, 23rd Ward)

O2013-7736 A substitute ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-022 (25.148) to allow the issuance of additional alcoholic liquor licenses on portion of Damen Avenue. (Alderman Solis, 25th Ward)
