Approval of the October 2019 Rule 45 Report of the Committee on License and Consumer Protection

02019-6960 An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-023 (9.8) to allow the issuance of additional packaged goods licenses on portion of 103rd Street. **(Alderman Beale, 9th Ward)**

02019-8027 An ordinance to amend Section 244-140 of the Municipal Code of Chicago prohibiting peddling in portion of the 3rd and 4th Wards. **(Aldermen King, Dowell)**

02019-8021 An ordinance to amend the Municipal Code of Chicago designating the 31st precinct of the 11th Ward as Restricted Residential Zone prohibiting additional shared housing and vacation rentals. **(Alderman Thompson, 11th Ward)**

02019-7999 An ordinance to amend the Municipal Code of Chicago lifting subsection 4-60-023(12.285) to allow additional packaged goods licenses on portion of Archer Avenue. **(Alderman Cardenas, 12th Ward)**
