PAGE 1 CONTAINS MAYORAL TEXT AMENDMENT O2024-0012427, THAT MODIFIES REGULATIONS FOR SIGNS WITHIN THE MICHIGAN AVENUE AND STATE ST SPECIAL SIGN DISTRICT. I MOVE PASSAGE OF THIS ITEM BY THE LAST MOST FAVORABLE ROLL CALL VOTE OF THE FINANCE COMMITTEE REPORT AND THE ASSOCIATED UNSUCCESSFUL MOTION TO RECONSIDER.

PAGE 1 ALSO CONTAINS MAYORAL TEXT AMENDMENT O2024-0012428, THAT AMENDS THE USE OF FUNDS FOR ADMINISTRATIVE, REPORTING AND MONITORING OF THE CITY WIDE ADOPT A LANDMARK FUND. I MOVE PASSAGE OF THIS ITEM BY THE SAME MOTION IF THERE IS NO OBJECTION.

PAGE 1 ALSO CONTAINS TEXT AMENDMENT O2024-0012418, THAT AMENDS PERMITTING FOR URBAN FARM OPERATIONS IN DC AND DX ZONING DESIGNATIONS. I MOVE PASSAGE OF THIS ITEM BY THE SAME MOTION IF THERE IS NO OBJECTION.

MOVING PAGES ONE THROUGH ELEVEN CONTAIN VARIOUS MAP AMENDMENTS IN THE 1ST, 3RD, 8TH, 12TH, 24TH, 25TH, 26TH, 27TH, 29TH, 32ND, 33RD, 34TH, 36TH, 39TH, 40TH, 42ND, 43RD, 44TH, 47TH, 48TH, 49TH, AND 50TH WARDS. I MOVE PASSAGE OF THESE ITEMS BY THE SAME MOTION IF THERE IS NO OBJECTION.
