PAGE CONTAINS THE RE-REFERAL OF DOCUMENT NO. 02024-0009659 TO THE COMMITTEE ON HOUSING AND REAL ESTATE. I MOVE PASSAGE OF THIS ITEM BY THE LAST MOST FAVORABLE ROLL CALL VOTE OF THE FINANCE COMMITTEE REPORT AND THE ASSOCIATED UNSUCCESFUL MOTION TO RECONSIDER.

PAGE 1 ALSO CONTAINS DOCUMENT NO. O2024-0005958, THE AMENDMENT OF MUNICIPAL CODE CHAPTERS 14X-12 AND 14A-3 REGARDING REGULATION AND REGISTRATION OF VACANT OR ABANDONED COMMERCIAL STOREFRONTS. I MOVE PASSAGE OF THIS ITEM BY THE SAME MOTION IF THERE IS NO OBJECTION.
