(7) AMENDMENT OF MUNICIPAL CODE TITLES 2, 9, 11 - O2026-0024966

Amendment of Municipal Code Titles 2, 9, and 11 regarding fines for illegal dumping and adding a new Section 2-14-132 authorizing impoundment of vehicles used in fly dumping.
