ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

ACOUSTIC TECHNOLOGY SERVICES

SECTION 1: The Executive Director of the Public Safety Administration, in consultation with the Superintendent of Police and the Corporation Counsel as to the form and legality, shall negotiate, enter into, and execute a contract extension, renewal, or new contract for acoustic gunshot detection technology services. Such contract shall: (1) be for a term of not less than 24 months; (2) ensure that there is no interruption to current acoustic gunshot detection services; and (3) be on the same material terms as the existing contract or be a reference contract, as defined in Section 2-92-649 of the Municipal Code of Chicago, with substantially the same material terms as the existing contract.

SECTION 2: This contract extension, renewal, or new contract must come back to the City Council within 60 days for approval.

SECTION 3: This ordinance shall be effective upon passage and approval
