(29) ORDER FOR THE COMMISSIONER OF THE DEPARTMENT OF TRANSPORTATION - Or2025-0016738

The Commissioner of the Chicago Department of Transportation is authorized and directed to negotiate and present to the City Council for approval an intergovernmental agreement with the Chicago Transit Authority (CTA), Regional Transportation Authority (RTA), or both, to establish a pilot program for safe pick-up/drop-off services for minors for public events at specific locations within the 29th ward.

AMENDMENT OF MUNICIPAL CODE CHAPTERS

(7) AMENDMENT OF MUNICIPAL CODE SECTION 17-10-1002 - O2025-0017545

Amendment of Municipal Code Section 17-10-1002 requiring all off-street parking areas and driveways to be improved with compacted base of 4-inch, all-weather, dustless materials. Sand or gravel is not considered a dustless material.

(7) AMENDMENT OF MUNICIPAL CODE SECTIONS 4-4-280 AND 11-4-1600 - O2025-0017568

Amendment of Municipal Code Sections 4-4-280 and 11-4-1600 establishing fines for public way vehicle dumping violations.

(8) AMENDMENT OF MUNICIPAL CODE TITLE 9 - O2025-0016749

Amendment of Municipal Code Title 9 by adding new Chapter 9-109 to utilize automated school bus enforcement systems to record violations regarding overtaking school buses.

(40) AMENDMENT OF MUNICIPAL CODE SECTION 9-76-160 - SO2025-0017559

Amendment of Municipal Code Section 9-76-160 requiring city departments to notify police within two days of police impoundment to begin the process.

(3) MOLLISON WORLD ELEMENTARY SCHOOL - O2025-0017351

An ordinance authorizing and directing the Department of Transportation to exempt MOLLISON WORLD ELEMENTARY SCHOOL from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 4415 South Martin Luther King Drive.

(4) "HONORARY REV. DR. LEROY SANDERS WAY" - O2025-0016867

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate East 46th Street, between South Ellis Avenue and South Greenwood Avenue as "HONORARY REV. DR. LEROY SANDERS WAY."

(6) LAWRENCE CALVIN D'ANTIGNAC WAY - O2025-0017382

An ordinance authorizing and directing the Department of Transportation to exempt LA LOCANDA from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 5129 South Archer Avenue.

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate South Throop Street from West 21st Street and West Cermak Road. as "HONORARY GILBERTO VILLASENOR SR. AND IGNACIO VILLASENOR ST."

(25) HONORARY LUCIA "LUCY" GUTIERREZ WAY - O2025-0017565

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate West 18th Street from Loomis Street to South Laflin Street as "HONORARY LUCIA "LUCY" GUTIERREZ WAY."

(26) 1539 N PULASKI ROAD HHDC, LP. - O2025-0017330

An ordinance authorizing and directing the Department of Transportation to exempt 1539 N PULASKI ROAD HHDC, LP. from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 1539 North Pulaski Road.

(26) JAMES LOWELL ELEMENTARY SCHOOL - O2025-0017331

An ordinance authorizing and directing the Department of Transportation to exempt JAMES LOWELL ELEMENTARY SCHOOL from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 3320 West Hirsch.
