MISCELLANEOUS ITEMS:

WARD

(1) INTERIOR GARDEN SERVICES, INC. - O2025-0021748

An ordinance authorizing and directing the Department of Transportation to exempt INTERIOR GARDEN SERVICES, INC. from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 1474 West Hubbard Street.

(2) DEVELOPMENT GROUP, LLC QUANTUM CAPITAL - O2025-0021525

An ordinance authorizing and directing the Department of Transportation to exempt DEVELOPMENT GROUP, LLC QUANTUM CAPITAL from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 1658 North Burling Street.

(2) MAR CHI-V, LLC - O2025-0021327

(10) ASSUMPTION GREEK ORTHODOX CHURCH WAY - O2025-0020477

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate the South Brainard Avenue between East 136th Street and East 137th Street as "ASSUMPTION GREEK ORTHODOX CHURCH WAY."

(16) MOTHER MABLE YANCY-IRVING WAY - O2025-0020300

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate the South Peoria Street from West 66th Street to West 67th Street as "MOTHER MABLE YANCY-IRVING WAY."

(16) PRIME AUTO GLASS & TINT, INC. - O2025-0021496

An ordinance authorizing and directing the Department of Transportation to exempt PRIME AUTO GLASS & TINT, INC. from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 5826 South Western Avenue.

(16) TREOPIA "TREE" THOMAS LANE - O2025-0015746

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate the 700 block of West 60th Street as "TREOPIA "TREE" THOMAS LANE."

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate the South Hamlin Avenue, from West 25th Street to West 26th Street as "MOISES GONZALEZ WAY."

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate the South Harding Avenue, from West 25th Street to West 27th Street as "RAUL MUNOZ WAY."

(25) WINDY CITY PARTS PRO'S, LLC - O2025-0021631

An ordinance authorizing and directing the Department of Transportation to exempt WINDY CITY PARTS PRO'S, LLC from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 3001 South Kedzie Avenue.

(28) FIREBIRD COMMUNITY ARTS - O2025-0021597

An ordinance authorizing and directing the Department of Transportation to exempt FIREBIRD COMMUNITY ARTS from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 3338 West Lake Street.

An ordinance authorizing and directing the Department of Transportation to exempt FLIPSIDE CUSTOM BODY SHOP NO.7 from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 4519 West Lake Street.

(28) HUB 32, LLC - O2025-0021964

An ordinance authorizing and directing the Department of Transportation to exempt HUB 32, LLC from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 132 North Kedzie Avenue.

(28) NEW MORNING STAR MB CHURCH WAY - O2025-0020523

An ordinance authorizing and directing the Commissioner of Transportation to take the actions necessary to honorarily designate the Hamlin Boulevard between Adams Street and Jackson Boulevard as "NEW MORNING STAR MB CHURCH WAY."

(28) SERGIO'S TRUCK & AUTO, LLC - O2025-0021598

An ordinance authorizing and directing the Department of Transportation to exempt SERGIO'S TRUCK & AUTO, LLC from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 4540 West Madison Street.

(28) WEST DETAILS III, LLC - O2025-0021601

An ordinance authorizing and directing the Department of Transportation to exempt WEST DETAILS III, LLC from the provisions requiring barriers as a prerequisite to prohibit alley ingress and/or egress to the parking facilities located at 825 South Western Avenue.
