Jaquie Algee [New member] is Director of External Relations at SEIU Healthcare. Jaquie is also a longtime civil rights activist. Jaquie has helped organize a multitude of marches, protests and rallies for workers' rights, civil rights, women's rights and more in Illinois and around the country. For example, she co-chaired the Illinois Women's March on Springfield that brought thousands to the Capitol in the spring of 2017 in support of the Equal Rights Amendment and justice for all women. Historically, Jaquie has also been at the forefront of several critical social movements, beginning with the gun violence prevention movement. When her only child, Kenneth, was shot and killed in 1995, Jaquie put "purpose over pain" and dedicated herself to "stopping senseless gun violence." She became a regional director of the Million Mom March, which was held on Mother's Day, May 14, 2000 in Washington, D.C. and other sister cities. With more than one million people participating across the nation, the march was the largest anti-gun violence rally to date.

Anwulika Anigbo [New member] asks ruminative questions. This fidelity to inquiry is the foundation of her work as a visual art, development director for the Invisible Institute, and mother. In each role, the questions and the conversations that arise from them facilitate the creation and recreation of narratives, systems, and spaces.
